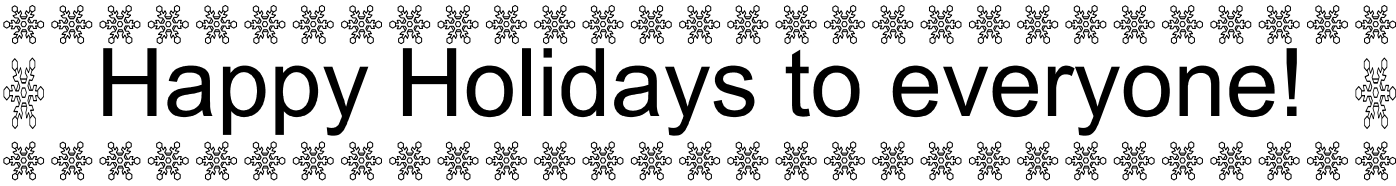

### *Various Spellings of the Family Name of Burkett -*

My maternal Ancestors are named Burkett. We pronounce it **BURK'** ett. All my life I have been told by Burkett relatives that it used to be Burkhart in Germany where our family originally lived. My

great Uncle James Henry Burkett "Uncle Jim" - the Burkett pecan expert - had a daughter named Kate who researched the family history from the time our Burketts left Germany until they migrated to and settled in Texas. I have read the letter in which Kate detailed her findings, namely the German spelling was Burkart and/or Burkhardt. Kate was well ed-ucated and knew how to do genealogical research. Also I should add that her father (my great Uncle Jim) was a diligent student of Burkett family history and often told me information he had obtained from his ancestors. He believed the name was formerly Burkhart.

This may be an appropriate time to say that as a professional genealogist I learned while taking university courses for a PhD in library science that various spellings of names occur in all public records, especially those kept in courthouses and city halls because the early clerks did not write clearly and correctly or preferred to spell by sound. Very often, people used the same spelling given on public records because the clerk "should know" how to spell.

All good genealogists research family history by reading histories of towns and counties where the family lived and may learn about various ways the family name was spelled or pronounced. For example, I have learned much family history by reading histories of North Carolina, Tennessee, and Texas. ■

I, HENRY BURKETT, of the County of Cannon and State of Tennessee, being now far spent in years, but of sound and disposing memory and knowing the uncertainty of life and the certainty of death which I must meet before a great many years, I hereby make and publish this my last Will and Testament revoking and making void all other wills by me at any time heretofore made, and by this Will I wish all my property both real and personal disposed of in the manner herein directed after it shall please God to take me away from this world. 1st It is my will and desire that all my just debts be paid after my death as soon as can be done, by my executors out of any money or other effects I may die possessed of, funeral expenses first to be paid. 2nd I hereby give and bequeath all my property both real and personal to my beloved wife Mary Burkett for and during her natural life and widowhood, with the exceptions hereafter stated to have and enjoy during her life or widowhood for her benefit and support and in case my stock of any sort should accumulate by increase after my death until there is more than my wife can take care of or have a use for then she is at liberty to sell off any part of surplus property and use the proceeds of sale for her own use and benefit. 3rd It is my will and I hereby will and bequeath unto all my children share and share alike equal portions of my estate both real and personal after the death of my beloved wife Mary Burkett and if any of my children shall be dead at the death of my wife leaving children, then their children are to represent the interest and be entitled to the portion of my estate which their parents would have been entitled to. 4th It is further my will and I hereby direct that after the death of my beloved wife Mary Burkett my executors will after advertising sell all my property both real and personal. The personal property to be sold on a credit of twelve months with good and approved security for the purchased money

and my real estate to be sold on time of one and two years credit in equal installments with good and approved security for the purchase money retaining a lien on the land until the purchased money is paid. I direct that my said Executors advertize my personal property for sale by posters and in the county News paper if any for at least thirty days and my real Estate in like manner for at least for forty days. I further direct that in case any of my children or grandchildren whose parents may be dead at that time are poor and needy and in judgement of my Executors it is best for them to do so, My executors are authorized to sell any of the sale notes for either real or personal property at the best price they can get not to exceed ten per cent discount and equally divide the proceeds among them entitled under this Will if any who are minors at the time their parts to be paid over to their regular guardians. 5th I hereby nominate and constitute and appoint Josephus Finley my Executor to this my last Will and Testament to carry out the same.

Given under my hand on this the 20th day of June A.D. 1874.

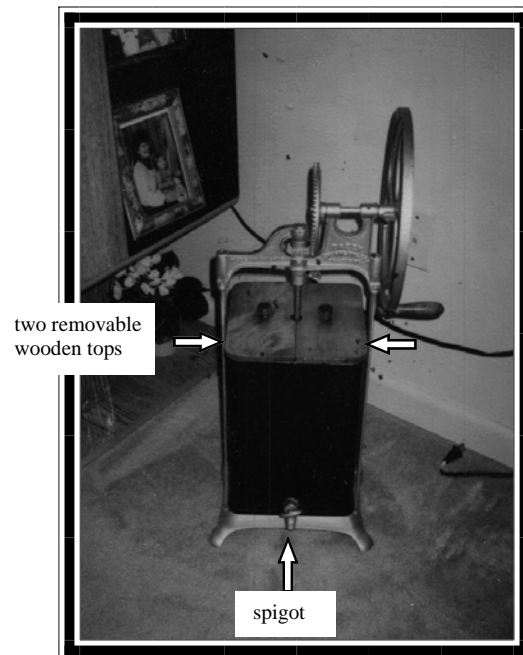

## ***A Rich Mans Churn -***

Probably many of our younger relatives have never seen a churn - much less one like this.



Some may even ask, "What is a churn?" Well, a churn is "a vessel in which milk or cream is agitated to separate the oily globules from the other parts and thus to obtain butter." All of our relatives had the type with a round wooden handle sticking straight up through the top and you sat beside it and worked it up and down which, while it wasn't real hard work, still took time and effort and as the milk thickened, it took more effort. But as you might

guess, somebody had to come up with an easier way. This churn is owned by Audy Majors who had all of the metal cleaned and repainted and the wood refinished to look like new. This picture doesn't really do justice to it. It was Patented in 1917 by the Dazey Churn & Mfg. Co. in St. Louis, Missouri. As you can see, you simply sat beside it and turned the wheel which, in turn, turned two paddles inside the churn. The spigot is to release the whey after the butter-making is completed. Now I hear somebody asking, "What is whey?" Whey is "the watery part of milk separated from the more thick or coagulable part." My Granny Burkett, like most others, had a round wooden mold which she then used to shape the butter in about one pound sizes. ■

### *A trip to McMinville -*

On Monday following the Bogle reunion on Saturday, Audy Majors and I drove up to visit Laura Durham and Frances Watson. They were unable to make the trip to Woodbury and Audy and I had promised to visit so away we went.

When we arrived, we phoned Laura for directions and, as we drove up in front of her house, one of her sons, Aaron, drove in behind us. We went in together and greeted Laura who then kept calling Frances until she got her and told her we had arrived so Frances came over to Laura's house.

Well, we had a great visit talking and looking at pictures - some of which I will share in this issue. Aaron was on his lunch time and we talked right on through that while his mother, Laura, kept him rounding up pictures for us to look at. Maybe we tired him out but it came time for him to go back to work for which we were sorry. He was a very comfortable and enjoyable person to be around and at least we got to meet him.

One of the pictures we came up with is the one in the next column which is Laura and Frances' parents - Tolbert Lee Burkett and Minnie Elrod. Tolbert was a brother of Almon Lee Burkett. Notice that Lee is the middle name for both. Not only that but Aaron, Laura's son mentioned above, has the middle name of Lee and, if you will look at the descendants chart on Page 6 under Elizabeth, you will find a daughter named Nora Lee. Now

that presents another question for me to work on. Where did the Lee come from? So far, I have managed to track down most of the common names in the family so now I'll have to go to work on this. Incidentally, Tolbert was 56 years of age when this picture was taken.

Well, since they were sisters who married brothers, that makes all of their children *double* first cousins! Furthermore, you will notice that Tolbert and his sister Elizabeth both married an Elrod - Minnie and Gum respectively - who were brother and sister so
